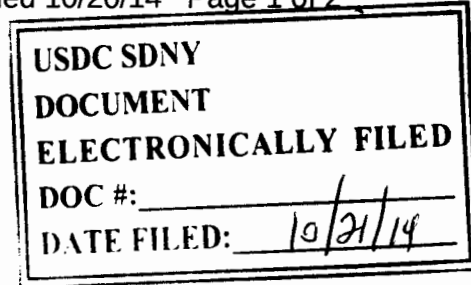

**JOINT MOTION TO STAY  
LITIGATION PENDING OUTCOME OF  
CONCURRENT PROCEEDING**

MEMO ENDORSED

Plaintiff Hockeyline, Inc. and Defendant STATS LLC (collectively, "the parties") respectfully move to stay the present litigation. On March 17, 2014, STATS petitioned the Patent Trial & Appeal Board (PTAB) of the USPTO for an *Inter Partes* Review (IPR) of U.S. Patent No. 6,725,107, challenging the validity of the asserted claims of the patent-in-suit. The PTAB entered its decision regarding IPR2014-00510 on September 25, 2014, instituting an administrative trial on STATS's petition. The trial process is expected to run through May 2015, with a final written decision thereafter. If the present motion is granted, the parties propose that the stay be lifted with the issuance of the written decision by the PTAB.

In support of this motion, the parties state that a stay will promote efficiency and judicial economy, and resolution of the IPR will likely simplify issues for this litigation. Neither party will be unduly prejudiced by the granting of this motion.
