**JUDGMENT**

Whereas the Court having held a trial in the above-captioned matter, and the jury having found defendants liable for patent infringement and having awarded Plaintiffs \$300,000 in compensatory damages; Plaintiffs having subsequently filed a motion for enhanced damages, which, which the Court having granted on December 18, 2013, awarding Plaintiffs \$900,000 in damages, but deferred ruling on pre- and post-judgment interest pending supplemental briefing, and the matter having come before the Honorable Samuel Conti, United States District Judge, Sitting by Designation, and the Court, on January 6, 2013, having rendered its Order instructing the Clerk to enter judgment in favor of Plaintiffs and against Defendants in the amount of \$900,000, which encompasses \$300,000 in compensatory damages and \$600,000 in enhanced damages, finding that Defendants shall be jointly and severally liable for the judgment, that the judgment shall also include pre-judgment interest at a rate of 3.25 percent, which shall be assessed only against the compensatory award of \$300,000 from August 1, 2008 through the date of the judgment, awarding post-judgment interest at a rate of 0.13 percent, and consistent with the Verdict, directing the Clerk to also enter judgment in favor of Counterclaimants Key Lighting, Inc. and B2Pro and against Counterdefendant Briese Lichttenchnick GMBH in the amount of \$2 in connection with

Counterclaimants' claim for trade libel, it is,


**ORDERED, ADJUDGED AND DECREED:** That for the reasons stated in the Court's Order dated January 8, 2013, judgment is entered in favor of Plaintiffs and against Defendants, jointly and severally, in the amount of \$953,424.66, which encompasses \$300,000 in compensatory damages and \$600,000 in enhanced damages, plus pre-judgment interest at a rate of 3.25 percent, on the compensatory award of \$300,000 from August 1, 2008 through the date of the judgment of \$53,424.66; Plaintiffs are also awarded post-judgment interest at a rate of 0.13 percent; and consistent with the Verdict, judgment is also entered in favor of Counterclaimants Key Lighting, Inc. and B2Pro and against Counterdefendant Briese Lichttenchnick GMBH in the amount of \$2 in connection with Counterclaimants' claim for trade libel.
