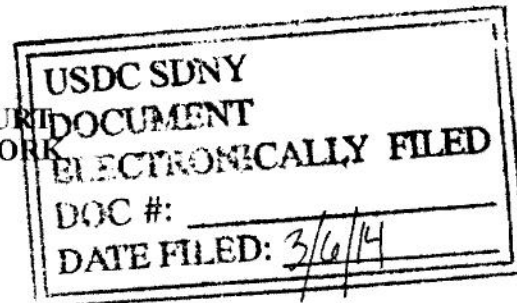

**STIPULATION AND [PROPOSED] ORDER OF DISMISSAL WITH AND WITHOUT
PREJUDICE SUBJECT TO CONFIDENTIAL SETTLEMENT AGREEMENT**

Hon Hai Precision Industry Co., Ltd. ("Hon Hai") and Wi-LAN Inc. ("Wi-LAN"), by and through their counsel of record, hereby stipulate as follows:

WHEREAS, the Parties have reached a confidential settlement agreement (the "Agreement") to settle the claims brought by Hon Hai against Wi-LAN and the counterclaims brought by Wi-LAN against Hon Hai in this action; and

WHEREAS, the Parties have agreed to dismiss some of their claims without prejudice and some of their claims with prejudice, as set forth and subject to the terms of the Agreement; and

WHEREAS, the Parties have agreed that each of them will bear its own attorneys' fees and costs.

NOW THEREFORE, the Parties agree and stipulate and respectfully request that the Court dismiss the claim for Declaratory Judgment of Non-Breach and the counterclaim for Breach of Contract in this action with prejudice, and dismiss all remaining claims and counterclaims in this action without prejudice, subject to the terms of the Agreement, pursuant to

Federal Rule of Civil Procedure 41(a)(2), with each party to bear its own attorneys' fees and costs. This Court retains jurisdiction to enforce the Parties' Agreement.
