WHEREAS, plaintiffs Pfizer Inc., Pfizer Limited and Pfizer Ireland Pharmaceuticals (collectively "Pfizer") commenced this action by filing complaints alleging infringement of U.S. Patent No. 6,469,012 (the "'012 patent") based on the filing by defendants of Abbreviated New Drug Applications seeking FDA approval to sell generic copies of Pfizer's Viagra® product prior to the expiration of the '012 patent;

WHEREAS, defendant Amneal Pharmaceuticals LLC ("Amneal") has filed an answer, defenses and counterclaims to Pfizer's complaint; and


WHEREAS, Pfizer and Amneal have entered into a settlement agreement, pursuant to which they have agreed to the dismissal of this action without prejudice, each side to bear its own costs and attorneys' fees;

IT IS HEREBY STIPULATED AND AGREED, that this action, including all claims and counterclaims, is dismissed without prejudice, as between Pfizer and Amneal, each side to bear its own costs and attorneys' fees.




