21 Pursuant to the Court's Order dated September 24, 2013 (Doc. 32), the parties
22 through their respective counsel of record, submit the following statement advising the Court of
23 the status of the defendant's pending Petition for *Inter Partes* Review under 37 C.F.R. § 42.100
24 concerning certain claims of the patent-in-suit ("IPR").

25 On August 23, 2013, the Patent Trial and Appeal Board of the United States Patent
