**JOINT STIPULATION OF DISMISSAL WITH PREJUDICE AS TO REMAINING
DEFENDANTS PURERFID, INC. AND SUPERCOM LTD.**

Whereas, Plaintiff Leighton Technologies LLC and remaining Defendants PureRFid, Inc. and SuperCom Ltd. (collectively the “SuperCom Defendants”), hereby stipulate and agree, by and through their respective undersigned attorneys, that all claims by Plaintiff Leighton Technologies LLC against the SuperCom Defendants, and all counterclaims by the SuperCom Defendants against Plaintiff Leighton Technologies LLC in the above-captioned action are hereby dismissed with prejudice, pursuant to Rule 41(a)(1)(A)(ii) of the Federal Rules of Civil Procedure subject to the terms of this Order and a Confidential Settlement and Non-Exclusive Limited Patent License Agreement.

NOW THEREFORE, it is ordered as follows:

1. The parties have signed a Non-Exclusive Limited Patent License Agreement effective as of July 7, 2014.

2. The claims by Leighton Technologies LLC against SuperCom Defendants are hereby dismissed with prejudice.

3. The claims and/or counterclaims by SuperCom Defendants against Leighton Technologies are hereby dismissed with prejudice.

4. Each party to bear its own costs and attorneys' fees.
