

# ASYLUM WIN FOR CAMEROONIAN WOMAN ABUSED BY POLICE

Over several years, our client was severely and repeatedly abused at the hands of the Cameroonian police for her political activity in support of Anglophones. In 2018, she managed to escape from police custody and fled to the United States. In 2019, the Asylum Office did not grant her affirmative asylum application and instead referred it to immigration court based on alleged inconsistencies. All of the alleged inconsistencies were third-party factual misunderstandings and misstatements, through no fault of our client. Our firm got involved after the referral to immigration court. The case languished on the immigration docket for several years due to a COVID backlog, and our client did not even have a hearing date listed in the court system. Eventually, we were able to file a motion to schedule a hearing on the merits to fulfill our client's goal of seeking a speedy resolution and hopefully reuniting with her sons, who are back in Cameroon. Ahead of the hearing, we submitted a fulsome evidentiary packet, including an expert report on country conditions, and a supporting brief.

On January 31, 2024, the immigration judge orally granted our client asylum at the conclusion of a merits hearing. The hearing involved our client's painful testimony reliving her experiences, detailed cross-examination from the government, and expert testimony from a country conditions expert our firm found and retained. Although the government wanted to delay further to obtain additional corroborating documentation, the immigration judge agreed that she had sufficient evidence to grant asylum on the spot. The court specifically held that our client's testimony was credible and that any alleged inconsistencies in the record were not the fault of our client. The government agreed to waive appeal, providing our client a complete and final victory. We are now applying to bring her sons over to the United States as derivative asylees, and next year, for her green card. As an asylee, our client will also be able to continue working. Throughout her time in the United States, our client has worked in healthcare, providing important societal contributions during the COVID-19 pandemic and beyond.
