PRACTICE HIGHLIGHTS

The firm continues its track record of success both inside and outside of the courtroom. Here are highlights from our recent wins:

SECURED \$60.5 MILLION SETTLEMENT, RESOLVING THE STATE OF MINNESOTA'S YOUTH VAPING EPIDEMIC CLAIMS AGAINST JUUL AND ALTRIA

Robins Kaplan partnered with Minnesota Attorney General Keith Ellison and Zimmerman Reed to sue e-cigarette manufacturer JUUL on behalf of the State of Minnesota for deceptively marketing its tobacco products and targeting Minnesota's youth for profit. After a three-week trial, a settlement was reached on the eve of jury deliberations. Over an eight-year period, JUUL and Altria will pay a combined total of \$60.5 million to the State of Minnesota. This is the largest per capita settlement of all 48 states and territories that have settled with JUUL. Read more here.

SECURED \$28 MILLION SETTLEMENT IN ALLEGED BREACH OF FIDUCIARY DUTIES LITIGATION AGAINST FORMER OFFICERS AND DIRECTORS OF FORPROFIT COLLEGE

Robins Kaplan secured a \$28 million settlement on behalf of the Receiver for Education Corporation of America (ECA), a privately held company that operated for-profit colleges across the United States. The settlement covers claims against several former officers and directors of ECA for allegedly breaching their fiduciary duties of care and loyalty to ECA for not giving students the ability to complete their education in the event the schools closed. SECURED \$12.2 MILLION SETTLEMENT IN DELIBERATE INDIFFERENCE JAIL CASE LEADING TO INMATE'S ARM AMPUTATIONS

Robins Kaplan attorneys secured a landmark \$12.2 million settlement on behalf of a client who suffered from the deliberate indifference of county personnel while he was detained at Scott County Jail in Shakopee, Minnesota, leading to multiple severe injuries. The settlement is believed to be the largest amount of its kind in Minnesota to date. Read more here.

BMO HARRIS ORDERED TO POST BOND FOR MORE THAN \$1,158,000,000 PENDING APPEAL OF OUR HISTORIC VERDICT

On July 25, 2023, a federal judge in St. Paul ordered BMO Harris Bank to post bond for more than \$1.158 billion as a result of the \$1 billion jury verdict and interest award Robins Kaplan secured against BMO on behalf of its client Douglas Kelley. This case arose from one of the largest Ponzi schemes in U.S. history. This ruling follows a historic November 2022 jury verdict against BMO awarding Kelley approximately \$564 million in damages, and the court's June 2023 order awarding Kelley approximately \$500 million in interest. This is the largest jury verdict in Minnesota history. Read more here.



PRO BONO

MAJOR VICTORY FOR FRIENDS OF THE BOUNDARY WATERS

Robins Kaplan LLP is pleased to announce a significant victory on behalf of its client, Friends of the Boundary Waters, in its campaign to prevent Twin Metals copper-nickel mine from developing a \$1.7 billion sulfide mining project on the edge of the Boundary Waters Canoe Area Wilderness (BWCAW). In September, a federal judge dismissed Twin Metals' lawsuit challenging the U.S. Department of Interior's cancellation of its mineral leases along the edge of the Boundary Waters, its rejection of its mining plan of operations, and denial of its preference right lease applications in other nearby areas that were withdrawn from mineral exploration. The United States District Court for the District of Columbia allowed the Friends of the Boundary Waters Wilderness and several other environmental groups and recreational businesses to intervene as defendants, granting their motion to dismiss Twin Metals' case in its entirety. 

The Women of Robins Kaplan (WoRK) organized service projects throughout all major offices during the months of May and June. These service projects were dedicated to Hollis Salzman (1965-2020), a trailblazing attorney, prominent female litigator, and beloved colleague and friend. The Boston WoRK members volunteered to support high school girls participating in Advocacy Day, specifically preparing the girls to meet with their legislators. The New York office compiled over 50 thank-you bags with handwritten notes for Jumpstart's corps of college volunteers. In addition, our New York office collected donations for the organization Friends Shelter. The Los Angeles team volunteered at the Westside Food Bank, where they sorted boxes of donated corn into 199 bags to be distributed to partner agencies. The Minneapolis office packed personal care kits for the organization People Serving People, an emergency shelter for families experiencing homelessness in Minnesota.
