We got a chance to catch up with former Robins Kaplan attorneys China Boak Terrell and Tony Beasley to see what they are up to now. Read on to check out their current endeavors and accomplishments!



CHINA BOAK TERRELL

Chief Executive Officer American Communities Trust, Inc. Robins Kaplan Associate 2002 - 2004

Where are you working now? How long have you worked there?

I'm the CEO of American Communities Trust, Inc. We're a public charity with our own real estate projects so I am both a nonprofit developer and a developer's consultant. I joined in 2016 right after going back to grad school to get my MPA from Harvard's Kennedy School.

What made you decide to take this career path?

In 2005, I had emergency open-heart surgery that changed my life. I determined then that if God blessed me to live, I would turn my volunteer work into a career so that I could help build up communities and uplift people in a more impactful way.

What does a typical workday include for you?

Here's today's to-do list:

- Finish Martha's questionnaire she has been so patient!
- Ask lender for revised term sheet to leverage loan through new markets tax credit structure.
- Get Elaine to pre-school!
- Work with staff on press release for community tree planting event.
- Draft pitch document for construction training program for New Jersey client.
- Conference with legal and financial team to settle on structure for next financial closing on \$10M.
- Pick up Elaine from pre-school!
- Shift gears entirely and invite donors to make campaign contributions while making dinner!

What is the most fulfilling part of your job?

I love rejoicing with residents that we're finally bringing about the change they've been demanding for so long. In Baltimore, we cleaned up four acres of environmental pollution that the city left behind after it abandoned an old city yard. The site was so blighted that it became the perfect filming location for the HBO series, the Wire. So far, we've raised over \$13 million to transform that brownfield and also renovate the historic buildings. We've also raised more than \$1.5 million in incentives for our small business tenants, including our black-owned businesses. We've got lots more work to do, but we can see the reawakened hope in the eyes of the people we serve. Restoration and new economic activity completely raise the bar of possibility. Is there anything in particular you learned while working at Robins Kaplan that is useful to you in your current role?

At Robins Kaplan, I learned to be a pioneer—to be unafraid to play the long game in cracking a code that isn't solved yet, but that would benefit everyone if solved. That paradigm leads our fearlessness in problem solving every day. And thankfully, Robins Kaplan also taught me that a little swashbuckling is good for team morale!


If you are willing, please share some information about your favorite hobbies or interests that fill your free time.

I'm running for office! Robins Kaplan certainly taught me that if you work at solving a challenge long enough, you'll see the policy changes that need to be made to improve the whole system. So, I'm running for delegate to the Maryland Legislature. My website is <u>chinaterrell.com</u>. That, plus trying to get in quality time with my husband and raising our four-year old, fills all the free time for now.

If you could create a new law or policy what would it be?

I would pass the Biden Administration's proposed housing policies, especially the Neighborhood Homes Investment Act. And I would slash Baltimore City's property tax from 2.25% to .86% to be competitive with our neighbors, including DC.

It could be a "Halley's Comet" opportunity: If we could implement real and personal property tax reform now, timed with the passage of Biden's accelerants for home ownership, then we could completely eradicate Baltimore's severe housing abandonment problem in under 10 years. We could also close the 21-percentage point gap between Baltimore's homeownership rate (47.8%) and Maryland's homeownership rate (68.8%). What a turbocharge that would be for our economy and our region!

Where are you working now? How long have you worked there?

Microsoft - 1 year in March

What made you decide to take this career path?

As my family grew, I wasn't sure that law firm litigation was the life for me anymore (as much as I enjoyed it). I started looking for in-house positions that would allow me to grow as a lawyer, maintain a focus on high technology, and help balance things out at home. A couple of former colleagues had become product support attorneys at Microsoft and spoke highly of the company, the culture, and their job satisfaction. I decided to give it a shot, and I'm glad I did.

What does a typical workday include for you?

As a "frontline" product support attorney, I am the first call for a whole host of issues that my clients might run into - anything from inbound IP licensing to open source compliance and privacy. I give advice, help draft agreements, and provide an avenue to subject matter experts within the legal department when necessary. I am on calls with engineers and product managers and providing consults most of the day, with a lot of email and Teams chats in between. And I am the legal representative of "product truth" within the broader organization for the groups I support.

What is the most fulfilling part of your job?

It's great to be an extension of the product teams - I'm truly invested in their success. We recently launched a new product, and I'm very excited to see a year's worth of hard work in prototyping, development, customer research (and of course, painstaking legal compliance and pathfinding) come into public focus for the first time.

Is there anything in particular you learned while working at Robins Kaplan that is useful to you in your current role?

Even though I'm no longer litigating, the lessons I learned at Robins still persist. My mentors and colleagues at Robins taught me how to be detail-driven, how to translate between technological and legal or lay audiences, and how to lawyer creatively in order to deliver the best client service.

I have three kids - Mo (5 ½), Sonny (2) and Kai (7 months), and they are pretty much my hobbies and interests. And I'd have it no other way! But, I also like to golf when possible and I'm desperately awaiting the end of the pandemic so I

If you could create a new law or policy what would it be? We need a comprehensive, federal legal framework for data protection, privacy, and responsible artificial intelligence. A state-by-state framework is starting to emerge and it will create a lot of work for enterprising law firms, but a lot of headaches for those of us trying to release products!

ROBINS KAPLAN FILES U.S. SUPREME COURT AMICUS BRIEF ON BEHALF OF FORMER U.S. ATTORNEYS

Robins Kaplan LLP filed an amicus brief at the United States Supreme Court in a matter that the firm is handling pro bono on behalf of a group of former United States Attorneys. The case, United States v. Cooley, concerns the scope of tribal law enforcement's search and seizure authority over non-Natives on the Reservation. **Tim Purdon** and **Brendan Johnson**, both former U.S. Attorneys who co-chair the firm's American Indian Law and Policy Group, are amici in the brief.

"As former U.S. Attorneys who prosecuted federal crimes on Reservations, the ten amici in this brief are all deeply familiar with the jurisdictional challenges facing federal, state, and tribal law enforcement officers and prosecutors as they endeavor to fight crime in those communities," says Purdon. "I am pleased to have the firm support us on this important pro bono matter which will help strengthen public safety for American Indian Tribes across the country."

Robins Kaplan's pro bono program has a long-standing commitment to representing American Indian Tribes across the U.S. The firm's work on behalf of Tribes includes representation of the Rosebud Sioux Tribe in a lawsuit against the federal government after it closed the only hospital emergency room on the Rosebud reservation and an important North Dakota Voting Rights case for the Standing Rock Sioux Tribe and the Spirit Lake Nation. This work has earned the firm recognition on the National Law Journal's Pro Bono Hot List.

"We are glad to support Tim, Brendan, and their fellow former U.S. Attorneys in this important matter concerning public safety for Tribal communities," said Logan Drew, chair of Robins Kaplan's Pro Bono Committee. "We continue our commitment to work on issues important to American Indian Tribes."

Robins Kaplan attorney **Eric Magnuson** and Robins Kaplan alumni Eric Boettcher worked on this pro bono matter.



TIME-SAVERS FOR ONLINE READING

TIP #1: On your computer: Ditch your mouse's scroll wheel or your keyboard's down arrow key; instead, use your spacebar!
