
MANSFIELD RULE: BOOSTING DIVERSITY IN LEADERSHIP

Robins Kaplan signed on to participate in the Mansfield Rule, powered by Diversity Lab, which certifies law firms that consider at least 30% women, LGBTQ+, and minority lawyers for senior-level hiring opportunities and significant leadership roles.

The discussion brought needed attention to the importance of providing purposeful employment opportunities for people of all abilities.
